- On December 19<sup>th</sup> and 20<sup>th</sup>, Royal Electric installed the Runway 08 PAPI system.
  For it to be commissioned into service, the FAA needs to perform a flight check,
  and that is scheduled for January 28<sup>th</sup>. Royal Electric will be on site for the flight
  check in the event adjustments are needed. Once completed, the system will be
  commissioned into service.
- The Credit Card Machine at the fuel farm went down on December 19<sup>th</sup>. The
  credit card processing company made an error that affected our system, so staff
  had to authorize cards in the terminal building for a total of three days –
  consequently limiting our fueling operations to business hours only.
- Staff began working with Streamline to implement the ADA compliance updates for the District's website. There is a design and review call scheduled for January 22<sup>nd</sup>. We anticipate the new website to be up and running by February 19<sup>th</sup>, 2025.
- The construction agreement for the terminal building is currently under review by legal counsel. Staff are hopeful to present the agreement for consideration at the February 12<sup>th</sup> Board of Directors meeting.
- Staff completed the required 2024 Sexual Harassment Prevention/ Hostile work Environment training. Airport Management also completed Ethics Training for 2024.
- The Special District Leadership Foundation (SDLF), District Transparency Certificate of Excellence Award application has been completed. Two local leaders; Glenn Jacklin, General Manager of the Big Bear City Community Services and Sandy Benson, General Manager of Mountain Transit, reviewed the application packet for accuracy and completion by following a checklist provided by SDLF. Board Secretary Rebecca Cannon sent the application packet to SDLF for review and consideration. The review process typically take a few weeks.
- Helicopter Big Bear is back and began operating December 20<sup>th</sup>.




